

# **Clinical Policy: Non-Formulary and Formulary Contraceptives**

### **Description**

This is a general prior authorization criteria for approval of non-formulary and formulary contraceptives.

## FDA Approved Indication(s)

For the prevention of pregnancy

## Policy/Criteria

Provider must submit documentation (such as office chart notes, lab results or other clinical information) supporting that member has met all approval criteria.

It is the policy of health plans affiliated with Centene Corporation<sup>®</sup> that non-formulary and formulary contraceptives are **medically necessary** when the following criteria are met:

## I. Initial Approval Criteria

- **A. Contraceptive Therapy** (must meet all):
  - 1. One of the following requirements is met (a or b):
    - a. MD attests that the generic or brand product is medically necessary;
    - b. Request is for product placement on Tier 0.

Approval duration: Duration of request or 12 months, whichever is less

#### **B.** Other diagnoses/indications

1. Refer to HIM.PHAR.21 if diagnosis is NOT specifically listed under section III (Diagnoses/Indications for which coverage is NOT authorized).

## **II. Continued Therapy**

- **A. Contraceptive Therapy** (must meet all):
  - 1. Currently receiving medication via Centene benefit or member has previously met initial approval criteria;
  - 2. Documentation that continued contraceptive therapy is required.

**Approval duration: 12 months** 

<u>VERY IMPORTANT: Once approval has been entered in the system you must enter exception for copay code (drug needs to pay on Tier 0) and exception for subject to deductible code for the requested drug.</u>

1. Currently receiving medication via Centene benefit and documentation supports positive response to therapy.

Approval duration: Duration of request or 12 months (whichever is less); or

2. Refer to HIM.PHAR.21if diagnosis is NOT specifically listed under section III (Diagnoses/Indications for which coverage is NOT authorized).

## III. Diagnoses/Indications for which coverage is NOT authorized:

**A.** Non-FDA approved indications, which are not addressed in this policy, unless there is sufficient documentation of efficacy and safety according to the off-label use policy – HIM.PHAR.21 or evidence of coverage documents.
