Description

The following are inhaled corticosteroids requiring prior authorization: ciclesonide (Alvesco®) and budesonide (generic inhalation suspension, Pulmicort Respules®).

FDA approved indication

Alvesco and Pulmicort Respules are indicated for the treatment of asthma.

Policy/Criteria

Provider must submit documentation (including office chart notes and lab results) supporting that member has met all approval criteria

I. Initial Approval Criteria**A. Asthma** (must meet all):

1. Diagnosis of asthma;
2. Member meets one of the following (a or b):
 - a. Request is for Alvesco, and failure of one formulary inhaled corticosteroid (Asmanex Twisthaler, Flovent, Pulmicort Flexhaler, QVAR) at up to maximally indicated doses unless contraindicated or clinically significant adverse effects are experienced;
 - b. Request is for budesonide inhalation suspension or Pulmicort Respules, and member meets one of the following (i or ii):
 - i. Age between 1 to 8 years;
 - ii. Documented inability to use inhaler devices;
3. Dose does not exceed:
 - a. Alvesco: 320 mcg twice daily;
 - b. Budesonide inhalation suspension or Pulmicort Respules: 1 mg/day.

Approval duration: 12 months

B. Other diagnoses/indications

1. Refer to HIM.PHAR.21 if diagnosis is NOT specifically listed under section III (Diagnoses/Indications for which coverage is NOT authorized).

II. Continued Therapy**A. Asthma** (must meet all):

1. Currently receiving medication via Centene benefit or member has previously met initial approval criteria;
2. Documentation of positive response to therapy;
3. If request is for a dose increase, new dose does not exceed:

- a. Alvesco: 320 mcg twice daily;
- b. Budesonide inhalation suspension or Pulmicort Respules: 1 mg/day.

Approval duration: 12 months

B. Other diagnoses/indications (must meet 1 or 2):

1. Currently receiving medication via health plan benefit and documentation supports positive response to therapy.

Approval duration: Duration of request or 12 months (whichever is less); or

2. Refer to HIM.PA.21 if diagnosis is NOT specifically listed under section III (Diagnoses/Indications for which coverage is NOT authorized)

III. Diagnoses/Indications for which coverage is NOT authorized:

- A. Non-FDA approved indications, which are not addressed in this policy, unless there is sufficient documentation of efficacy and safety according to the off label use policy – HIM.PHAR.21 or evidence of coverage documents
