### **Description**

The following are topical testosterone agents requiring prior authorization: testosterone transdermal system (Androderm®)

### **FDA approved indication**

Topical testosterone agents are indicated:

- For the treatment of primary hypogonadism (congenital or acquired)
- For the treatment of hypogonadotropic hypogonadism (congenital or acquired)

Limitation of use:

- Safety and efficacy of Androderm in men with “age-related hypogonadism” have not been established.
- Safety and efficacy of Androderm in males less than 18 years old have not been established.
- Topical testosterone products may have different doses, strengths, or application instructions that may result in different systemic exposure.

### **Policy/Criteria**

Provider must submit documentation (including office chart notes and lab results) supporting that member has met all approval criteria

#### **I. Initial Approval Criteria**

##### **A. Hypogonadism (primary and hypogonadotropic types) (must meet all):**

1. Diagnosis of hypogonadism;
2. Failure of testosterone cypionate or testosterone enanthate injection at up to maximally indicated dose unless contraindication or clinically significant adverse effects are experienced (*Failure is demonstrated by lower than normal total testosterone levels as compared to laboratory reference values*);
3. Dose does not exceed the FDA approved maximum recommended dose for the relevant drug.

**Approval duration: 12 months**

##### **B. Other diagnoses/indications**

1. Refer to HIM.PHAR.21 if diagnosis is NOT specifically listed under section III (Diagnoses/Indications for which coverage is NOT authorized).

#### **II. Continued Therapy**

##### **A. Hypogonadism (primary and hypogonadotropic types) (must meet all):**

### Topical Testosterone

1. Currently receiving medication via Centene benefit or member has previously met initial approval criteria;
2. Documentation of positive response to therapy;
3. Dose does not exceed the FDA approved maximum recommended dose for the relevant drug.

**Approval duration: 12 months**

**B. Other diagnoses/indications (must meet 1 or 2):**

1. Currently receiving medication via health plan benefit and documentation supports positive response to therapy.

**Approval duration: Duration of request or 12 months (whichever is less); or**

2. Refer to HIM.PA.21 if diagnosis is NOT specifically listed under section III (Diagnoses/Indications for which coverage is NOT authorized)

**III. Diagnoses/Indications for which coverage is NOT authorized:**

- A.** Non-FDA approved indications, which are not addressed in this policy, unless there is sufficient documentation of efficacy and safety according to the off label use policy – HIM.PHAR.21 or evidence of coverage documents
