# Description

Guanfacine ER (Intuniv<sup>®</sup>) is a central alpha<sub>2A</sub>-adrenergic receptor agonist.

# FDA approved indication

Intuniv is indicated for the treatment of attention deficit hyperactivity disorder (ADHD) as monotherapy and as adjunctive therapy to stimulant medications.

# **Policy/Criteria**

*Provider* <u>must</u> submit documentation (including office chart notes and lab results) supporting that member has met all approval criteria

# I. Initial Approval Criteria

# A. Attention Deficit Hyperactivity Disorder (must meet all):

- 1. Diagnosis of attention deficit hyperactivity disorder (ADHD);
- 2. Age  $\geq$  6 years;
- 3. Failure of a formulary stimulant from the amphetamine class at up to maximally indicated doses unless contraindicated or clinically significant adverse effects are experienced to any amphetamine product;
- 4. Failure of a formulary stimulant from the methylphenidate class at up to maximally indicated doses unless contraindicated or clinically significant adverse effects are experienced to any methylphenidate product;
- 5. Failure of a 4 week trial of immediate-release guanfacine dosed two to three times daily unless clinically significant adverse effects are experienced;
- 6. Request is for once daily dosing;
- 7. Dose does not exceed the following:
  - a. Ages 6-12 years: 4 mg per day;
  - b. Age  $\geq$  13 years: 7 mg per day.

#### **Approval duration: 12 months**

#### **B.** Other diagnoses/indications

1. Refer to HIM.PHAR.21 if diagnosis is NOT specifically listed under section III (Diagnoses/Indications for which coverage is NOT authorized)

# **II.** Continued Therapy

#### A. Attention Deficit Hyperactivity Disorder (must meet all):

- 1. Currently receiving medication via Centene benefit or member has previously met initial approval criteria;
- 2. Documentation of positive response to therapy;
- 3. Request is for once daily dosing;

- 4. If request is for a dose increase, new dose does not exceed the following:
  - a. Ages 6-12 years: 4 mg per day;
  - b. Age  $\geq$  13 years: 7 mg per day.

# **Approval duration: 12 months**

# **B.** Other diagnoses/indications (must meet 1 or 2):

1. Currently receiving medication via health plan benefit and documentation supports positive response to therapy.

Approval duration: Duration of request or 12 months (whichever is less); or

2. Refer to HIM.PHAR.21 if diagnosis is NOT specifically listed under section III (Diagnoses/Indications for which coverage is NOT authorized)

# III. Diagnoses/Indications for which coverage is NOT authorized:

A. Non-FDA approved indications, which are not addressed in this policy, unless there is sufficient documentation of efficacy and safety according to the off label use policy – HIM.PHAR.21 or evidence of coverage documents
